5. ORDINANCES FOR SECOND READING

A. 
The Town Attorney, Marty Cassini, read the ordinance into the record.

Mayor Pizzi made a motion to adopt the ordinance on second reading and the motion was seconded by Vice Mayor Mestre. All were in favor.


6. ADJOURNMENT
