A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, AUTHORIZING A WORK ORDER, PURSUANT TO CONTRACT 2021-43 FOR CIVIL ENGINEERING AND RELATED SERVICES, WITH EXP U.S. ("EXP") SERVICES, INC. **FOR PROFESSIONAL** ENGINEERING SERVICES FOR THE MIAMI LAKES GREEN 2.0, NW 146th STREET ROADWAY PROJECT; FOR AN AMOUNT NOT TO EXCEED ONE HUNDRED THOUSAND, SIX HUNDRED SIXTY FIVE DOLLARS AND **MODIFYING** THE **BUDGET APPROVED** ORDINANCE 23-318; PROVIDING FOR AUTHORITY OF TOWN OFFICIALS; AUTHORIZING THE TOWN MANAGER **EXPEND BUDGETED PROVIDING FUNDS**; INCORPORATION OF RECITALS;; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, during the November 2022 Town of Miami Lakes (the "Town") Council meeting, the Town passed Resolution 22-1884, which permitted the Town to apply for an accept a Florida Department of Transportation ("FDOT"), Transportation Alternatives Program ("TAP") grant to fund the Town's Green 2.0, N.W. 146th Street Roadway Improvement Projects ("Green 2.0"); and

WHEREAS, the Green 2.0 project will provide a 10 foot shared use pathway for both pedestrians and bicyclists, providing a key piece to connecting future cycling facilities no N.W. 87th Avenue and N.W. 89th Avenue, and providing for added pedestrian connectivity to persons traversing the Business Park West and students attending Barbara Goleman High School; and

WHEREAS, the TAP grant has provided the Town with funding in the amount of Five Hundred Forty One Thousand, Four Hundred Ninety Four Dollars, and in addition, the Town will provide Two Hundred Sixty Six Thousand, Seven Hundred Six Dollars from available People Transportation Trust Dollars; and

WHEREAS, during the November 9, 2022, Town of Miami Lakes (the "Town") Council meeting, the Town Council awarded Contract 2021-43300 to EXP U.S. Services, Inc. ("EXP") for Civil Engineering and Related Services; and

WHEREAS, Town Staff and EXP have negotiated the scope of work and fee for professional engineering services for: Work Order No. 13, for the Green 2.0, N.W. 146th Street Roadway Improvements Project, in an amount not to exceed One Hundred and Eight Thousand, Six Hundred Sixty Five Dollars and 00/100 (\$108,665.00), attached hereto as Exhibit "A."

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, AS FOLLOWS:

Section 1. Recitals. The foregoing Recitals are true and correct and incorporated herein by this reference.

Section 2. Approval of the Work Order The Town Council approves Work Order No. 13, with EXP U.S. Services, Inc. for Green 2.0, N.W. 146th Street Roadway Improvements Project, in an amount not to exceed One Hundred Eight Thousand, Six Hundred Sixty Five Dollars and 00/100 (\$108,665.00).

<u>Section 4.</u> <u>Authorization of Town Officials.</u> The Town Manager and/or his designee and the Town Attorney and/or his designee are authorized to take all steps necessary to implement Work Order No. 13.

Section 4. Authorization of Fund Expenditure. The Town Manager is authorized to expend budgeted funds for the following projects as described in Exhibit "A."

Section 5. Effective Date. This Resolution shall take effect immediately upon adoption.
