RESOLUTION NO. 24-1996

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, APPROVING ITB 2024-18 FOR THE AWARD OF A CONTRACT FOR GENERATOR AUTOMATED TRANSFER SWITCH (ATS) TO TAW POWER SYSTEMS, INC., DBA INTEGRATED POWER SERVICES, AUTHORIZING THE TOWN MANAGER TO TAKE ALL NECESSARY STEPS TO IMPLEMENT THE TERMS AND CONDITIONS OF THE CONTRACT; AUTHORIZING THE TOWN MANAGER TO EXPEND BUDGETED FUNDS; AUTHORIZING THE TOWN MANAGER TO EXECUTE THE CONTRACT; PROVIDING FOR INCORPORATION OF RECITALS; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, Chapter 2, Article V, Division 2, Section 2-155 of the Town Code provides that procurements more than \$15,000 shall require the use of competitive sealed bidding; and

WHEREAS, in accordance with Chapter 2, Article V, Division 2, Section 2-155 of the Town Code, the Town issued Invitation to Bid ("ITB") No. 2024-18, Authorizing to Award a Contract for Generator Automated Transfer Switch (the "Project"); and

WHEREAS, the ITB was advertised online via two public bidding websites, DemandStar and Public Purchase, and was physically posted in the Government Center Lobby; and

WHEREAS, the Town received three (3) bids from the following:

- 1) Critical Power Solutions Group, Inc. \$24,900.00
- 2) Green Alliance, Inc. \$41,000.00
- 3) TAW Power Systems, Inc., dba, Integrated Power Services ("IPS") \$17,502.72

WHEREAS, based on due diligence, Procurement determined that IPS was the lowest responsive and responsible bidder; and

WHEREAS, Procurement recommends awarding a contract to IPS in an amount not to exceed Seventeen Thousand Five Hundred and Two Dollars and 72/100 (\$17,502.72); and

WHEREAS, the Town Manager concurs with Procurement's recommendation and recommends the Town Council authorize the award of a contract to IPS for the generator automated transfer switch replacement in an amount not to exceed Seventeen Thousand Five Hundred and Two Dollars and 72/100 (\$17,502.72); and

WHEREAS, the Town Council approves the recommendations of the Town Manager and authorizes the Town Manager to enter into a contract with IPS for the generator transfer switch replacement.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, AS FOLLOWS:

Section 1. Recitals. The foregoing Recitals are true and correct and incorporated herein by this reference.

Section 2. Approval of the Contract. The Town Council hereby approves the award of a contract to TAW Power Systems, Inc., dba, Integrated Power Services for the generator in an amount not to exceed Seventeen Thousand Five Hundred Two Dollars and 72/100 (\$7,502.72) in substantially the same form as attached hereto as Exhibit "A" (hereinafter referred to as "Contract").

Section 3. Authorization of Fund Expenditure. The Town Manager, his designee and the Town Attorney are authorized to take all steps necessary to implement the terms and conditions of the Contract.

Section 4. Authorization of Town Officials. The Town Manager and/or his designee and the Town Attorney and/or his designee are authorized to take all steps necessary to finalize and carry out the terms of the agreement with TAW Power Systems, Inc., dba, Integrated Power Services.

Section 5. Execution of the Contract. The Town Manager is authorized to execute the Contract with TAW Power Systems, Inc., dba, Integrated Power Services, for the replacement of the Generator Automated Transfer switch in an amount not to exceed Seventeen Thousand Five Hundred Two Dollars and 72/100 (\$17,502.72) in substantially the same form as attached hereto as Exhibit "A", and to execute any extension and/or amendments to the Contract, subject to approval as to form and legality by the Town Attorney.

Section 6. Effective Date. This Resolution shall take effect immediately upon adoption.
