

**RESOLUTION NO. 24 - 2012**

**A RESOLUTION OF THE TOWN OF MIAMI LAKES, FLORIDA, PURSUANT TO TOWN CODE ARTICLE XII, DIVISION 2, NAMING A PARK PAVILION AT VETERANS PARK IN HONOR OF GARY CARDENAS; PROVIDING FOR INSTRUCTIONS TO TOWN MANAGER; PROVIDING FOR INCORPORATION OF RECITALS; PROVIDING FOR AN EFFECTIVE DATE.**

**WHEREAS**, during the June 2024 Town of Miami Lakes (the “Town”) Council Meeting, the Town Council approved the dedication of a park pavilion at Veterans Park in honor of Gary Cardenas; and

**WHEREAS**, Article XII, Division 2 of the Town Code, provides the exclusive method by which Town facilities can be dedicated and named; and

**WHEREAS**, pursuant to Article XII, Division 2 of the Town Code, on June 11, 2023 the Town Council considered and approved the naming of a park pavilion at Veterans Park in honor of Gary Cardenas; and

**WHEREAS**, pursuant to Article XII, Division 2 of the Town Code, on July 1, 2024 this Resolution was publicly notice in Community Newspaper; and

**WHEREAS**, pursuant to Article XII, Division 2 of the Town Code, on July 9, 2024 a public hearing regarding the dedication of a park pavilion at Veterans Park in honor of Gary Cardenas; and

**WHEREAS**, pursuant to Article XII, Division 2 of the Town Code, on August 13, 2024 a public hearing regarding the dedication of a park pavilion at Veterans Park in honor of Gary Cardenas; and

**WHEREAS**, after hearing testimony provided by Staff and the Public, the Town Council finds that a park pavilion at Veterans Park should be named in honor of Gary Cardenas.

**NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, AS FOLLOWS:**

**Section 1. Recitals.** The foregoing Recitals are true and correct and incorporated herein by this reference.

**Section 2.**     **Dedication of a Park Pavilion at Veterans Park.** Pursuant to the Town Code, the Town Council hereby adopts this resolution and instructs staff to properly dedicate a park pavilion at Veterans Park in honor of Gary Cardenas.

**Section 3.**     **Authorization of Town Officials.** The Town Manager and/or his designee are authorized to expend budgeted funds to create the necessary signage to achieve Section 2 of this Resolution.

**Section 4**     **Effective Date.** This Resolution shall be effective immediately upon adoption.


