

RESOLUTION NO. 24-2026

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, AUTHORIZING THE INCREASE IN THE HOURS OF FREEBEE ON-DEMAND SERVICE; AUTHORIZING THE TOWN MANAGER TO TAKE ALL NECESSARY STEPS TO IMPLEMENT THE TERMS AND CONDITIONS OF THE CONTRACT; AUTHORIZING THE TOWN MANAGER TO EXPEND BUDGETED FUNDS; AUTHORIZING THE TOWN MANAGER TO EXECUTE THE CONTRACT; PROVIDING FOR INCORPORATION OF RECITALS; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Town of Miami Lakes (the “Town”) uses Freebee On Demand Services in order to meet Town resident’s transportation needs; and

WHEREAS, currently the Town provides one hundred and eighty-eight (188) hours of service; and

WHEREAS, in order to provide Town residents with greater service, and reduce wait times, it is suggested that hours of service be increased from 188 to 218 hours; and

WHEREAS, this increase in hours represents a cost of Forty Nine Thousand, Five Hundred Thirty Two Dollars and 32/100 (\$49,532.32); and

WHEREAS, funding for this increase will come from transit contingency and carryover funds; and

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, AS FOLLOWS:

Section 1. **Recitals.** The foregoing Recitals are true and correct and incorporated herein by this reference.

Section 2. Authorizing the Increase in Freebee On-Demand Transportation Hours of Operation. The Town Council authorizes the Manager to take any action necessary to increase Freebee On-Demand transportation hours of operation from one hundred eighty-eight (188) to two hundred eighteen (218) hours.

Section 3. Authorization of Fund Expenditure. The Town Manager is authorized to increase the amount expended for Freebee On-Demand Services be increased in an amount of Forty-Nine Thousand Five Hundred Thirty-Two Dollars and 32/100 (\$49,532.32), for a total annual expenditure of Four Hundred Sixty Thousand, Eight Hundred Eighty Dollars and 84/100 (\$460,880.84).

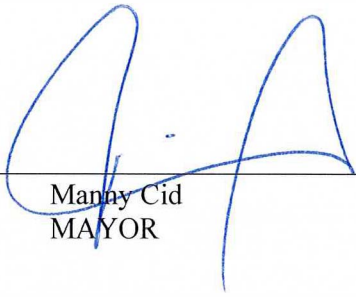
Section 4. Effective Date. This Resolution shall take effect immediately upon adoption.

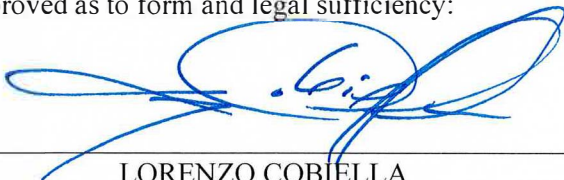
