

## Town of Miami Lakes Business Impact Estimate

Approving The Devising Of Certain Land Owned By The Town Of Miami Lakes In Consideration For Land Owned By Miami-Dade County

This Business Impact Estimate is provided in accordance with section 166.041(4), Florida Statutes. An ordinance of the Town of Miami Lakes, Florida; approving the devising of certain land owned by the Town of Miami Lakes in consideration for land owned by Miami-Dade County. The purpose of the request is facilitate required upgrades to an existing sanitary sewer pump station serving the south east area of the Town.

- 2. An estimate of the direct economic impact of the proposed ordinance on private, for-profit businesses in the Town, if any: N/A

- 4. Additional information the governing body deems useful (if any):

The Miami-Dade Water and Sewer Department ("WASD") owns and operates Pump Station 329, which is located on the County Property located within 6350 Lake Patricia Drive, Miami Lakes, Florida, bearing Folio No. 32-2024-003-2720 ("County Property"), as depicted and legally described in Exhibit "A". To bring Pump Station 329 into compliance with the requirements and regulations set forth by United States Environmental Protection Agency (USEAP), the County must complete upgrades to Pump Station 329 by December 31, 2025. As part of the upgrades, the County is proposing to remove and relocate Pump Station 329, at its sole cost and expense, to an area within the Town Property that would provide WASD with better access to the new upgraded Pump Station 329 and would decrease the number of disruptions to the Town Property. The upgraded pump station will provide greater sewer capacity to the surrounding areas. To accommodate the relocation of the new upgraded Pump Station 329, the County requested that the Town convey a portion of the parcel of the Town Property located at 6350 Lake Patricia Drive, Miami Lakes, Florida, bearing Folio No. 32-2024-0003-2750 to the County. The parcel to be conveyed by the Town to the County ("Town Parcel") totals 1,742 square feet and is depicted and legally described in Exhibit "B". In exchange for the Town conveying the Town Parcel to the County, the County will convey the County Property to the Town at no cost to either Party. The scope of the pump station upgrades includes the demolition of the existing pump 0329, construction of the new upgraded station within the requested property, landscaping, potential removal of existing tree, and tree mitigation.
