A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, AUTHORIZING A WORK ORDER, PURSUANT TO CONTRACT 2021-43 FOR CIVIL ENGINEERING AND RELATED SERVICES, WITH CALTRAN ENGINEERING GROUP, INC., FOR N.W. 154th STREET AND PALMETTO EXPRESSWAY TURN LANE PROJECT, FOR AN AMOUNT OF TWENTY NINE THOUSAND NINE HUNDRED TWELVE DOLLARS AND 54/100 (\$29,912.54) NOT TO EXCEED **BUDGETED FUNDS; PROVIDING FOR AUTHORITY OF** TOWN OFFICIALS: AUTHORIZING THE TOWN MANAGER TO EXPEND BUDGETED FUNDS; PROVIDING FOR **INCORPORATION OF RECITALS; AND PROVIDING FOR AN EFFECTIVE DATE.**

WHEREAS, during the November 9, 2022, Town of Miami Lakes (the "Town") Council

meeting, the Town Council awarded Contract 2021-43 to Caltran Engineering Group, Inc. ("Caltran") for Civil Engineering and Related Services; and

WHEREAS, through State of Florida funding, the Town has secured monies for the

enhancement of turn lanes from N.W. 154th Street onto the Palmetto Expressway; and

WHEREAS, the Town has secured construction services and desires to retain a firm that

can conduct construction engineering inspection services; and

WHEREAS, Town Staff and Caltran have negotiated the scope of work and fee for construction and inspection services for the N.W. 154th Street and Palmetto Expressway Turn Lanes Project, Construction Engineering and Inspection (CEI) Services for an amount of twenty nine thousand nine hundred twelve dollars and 54/100 (\$29,912.54) not to exceed budgeted funds. as detailed in Exhibit "A"; and

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, AS FOLLOWS:

Section 1. Recitals. The foregoing Recitals are true and correct and incorporated herein by this reference.

<u>Section 2.</u> <u>Approval of the Work Order</u> The Town Council approves a work order, with Caltran Engineering Group, Inc., for construction engineering and inspection services to be performed for the N.W. 154th Street and Palmetto Expressway Turn Lanes Project, for an amount of twenty nine thousand nine hundred twelve dollars and 54/100 (\$29,912.54) not to exceed budgeted funds, as described in Exhibit "A."

<u>Section 3.</u> <u>Authorization of Town Officials.</u> The Town Manager and/or his designee and the Town Attorney and/or his designee are authorized to take all steps necessary to implement a work order with Caltran Engineering Group, Inc., as described in Exhibit "A."

<u>Section 4.</u> <u>Authorization of Fund Expenditure.</u> The Town Manager is authorized to expend budgeted funds for Work Order No. 3, with Caltran Engineering Group, Inc., as described in Exhibit "A," for an amount of twenty-nine thousand nine hundred twelve dollars and 54/100 (\$29,912.54) not to exceed budgeted funds.

Section 5. Effective Date. This Resolution shall take effect immediately upon adoption.
