

**RESOLUTION NO. 24- 2046**

**A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, APPROVING A FIVE-YEAR AGREEMENT WITH MIAMI-DADE COUNTY FOR THE PROVISION OF LOCAL POLICE SERVICES; PROVIDING FOR AUTHORITY OF TOWN OFFICIALS; PROVIDING FOR AUTHORITY TO EXPEND BUDGETED FUNDS; AND PROVIDING FOR AN EFFECTIVE DATE.**

**WHEREAS**, the Town of Miami Lakes (the “Town”) receives police services from Miami-Dade County’s Police Department via an Interlocal Agreement between the two governments; and

**WHEREAS**, the Town of Miami Lakes has been receiving municipal police services from Miami-Dade County’s Police Department since 2001. The current agreement is set to expire on September 30, 2024; and

**WHEREAS**, since March 2024, the Town along with the governments of Palmetto Bay and Cutler Bay, who also receive municipal police services from Miami-Dade County’s Police Department, have engaged Miami-Dade County to extend and to create uniformity in the three agreements; and

**WHEREAS**, the approximate value of the new agreement for the 24-25 fiscal year is Eleven Million Dollars (\$11,000,000); and

**WHEREAS**, during the June 2024 Council Meeting, the Town Council voted to approve a five-year agreement, with a three year notification of termination; and

**WHEREAS**, given the imminent transition from the County supervision of the police department to a sheriff, it is desirous to revise the termination clause from three (3) years to one (1) year; and

**WHEREAS**, the Town Manager recommends that the Town Council adopt and accept the newly revised agreement with Miami-Dade County Police Department for Police Services as attached hereto as Exhibit "A."

**NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, AS FOLLOWS:**

**Section 1.**     **Recitals.**     The foregoing Recitals are true and correct and incorporated herein by this reference.

**Section 2.**     **Adoption of a Five (5) Year Agreement with Miami-Dade County for Municipal Police Services.**     The Town Council hereby approves the revised Five (5) Year Agreement with Miami-Dade County Police Department for municipal police services more specifically described in Exhibit "A."

**Section 3.**     **Authorization of Town Manager.**     The Town Manager shall have all the requisite authority necessary to execute the revised Five (5) Year Agreement with Miami-Dade County Police Department in substantially the same form as attached hereto as Exhibit "A", and any other addendums or documents that may be necessary to carry out the agreement.


**Section 4.**     **Expense of Budgeted Funds.**     The Town Manager shall have the authority to expense budgeted funds.

**Section 5.**     **Effective Date.**     This Resolution shall take effect immediately upon adoption.
