RESOLUTION NO. 24-2048

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, APPROVING THE LEASE OF COPIER SERVICES IN AN AMOUNT NOT TO EXCEED BUDGETED FUNDS; AUTHORIZING THE TOWN MANAGER TO UTILIZE THE STATE OF FLORIDA NASPO VALUEPOINT COPIERS & MANAGED PRINT SERVICES CONTRACT FOR LEASING COPIERS WITH TOSHIBA AMERICAN BUSINESS SOLUTIONS, INC., FOR TOWN HALL, PURSUANT TO CHAPTER 2, ARTICLE V, DIVISION 2 SECTION 2-157 OF THE TOWN CODE; AUTHORIZING THE TOWN MANAGER TO TAKE ALL NECESSARY STEPS TO IMPLEMENT THE TERMS AND CONDITIONS OF THE CONTRACT; AUTHORIZING THE MANAGER TO EXPEND BUDGETED AUTHORIZING THE TOWN MANAGER TO EXECUTE THE CONTRACT; PROVIDING FOR INCORPORATION RECITALS; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, since 2020, the Town of Miami Lakes (the "Town") has relied on Toshiba leased copiers to provide Town staff with copying and printing means; and

WHEREAS, the Town's current contract with Toshiba, through the National IPA Contract R171405 (now known as OMNIA Partners Public Sector cooperative purchasing), is set to expire; and

WHEREAS, Chapter 2, Article V, Division 2, Section 2-157 of the Town Code, authorizes the purchase of goods and services from current contracts of other public, governmental, state/federal funded or non-profit entities, where the contracts have resulted from a formal competitive procurement process; and

WHEREAS, the Town intends to continue using Toshiba American Business Solutions for copying and print services at Town Hall through the newly available State of Colorado NASPO ValuePoint contract for Copiers and Managed Print Services.

WHEREAS, the Town intends to piggyback the State of Colorado Master Agreement Number: 188037 (State of Florida's Alternate Contract Source No. 44100000-24-NASPO-ACS) with NASPO ValuePoint Copiers and Managed Print Services, through Toshiba American Business Solutions, Inc., for copying and printing services in an amount not to exceed budgeted funds; and

WHEREAS, the Town Manager recommends authorization to access the State of Florida

Contract NASPO Value Point Copiers and Managed Print Services, through Toshiba American Business Solutions, Inc., in an amount not to exceed budgeted funds; and

WHEREAS, the Town Council approves of the Town Manager's recommendations.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, AS FOLLOWS:

Section 1. Recitals. The foregoing Recitals are true and correct and incorporated herein by this reference.

Section 2. Approval of the Contract. The Town Council hereby approves access to State of Colorado Master Agreement Number: 188037 (State of Florida's Alternate Contract Source No. 44100000-24-NASPO-ACS), with NASPO Value Point Copiers and Managed Print Services, through Toshiba American Business Solutions, Inc., in substantially the same form attached hereto as Exhibit "A" for these services in an amount not to exceed budgeted funds.

Section 3. Authorization of Town Officials. The Town Manager and/or his designee are authorized to take all steps necessary to utilize the State of Colorado Master Agreement Number: 188037 (State of Florida's Alternate Contract Source No. 44100000-24-NASPO-ACS), with NASPO Value Point Copiers and Managed Print Services, through Toshiba American Business Solutions, Inc., and to execute said contract on behalf of the Town, subject to approval as to form and legality by the Town Attorney. The Town Manager and/or his designee and the Town Attorney are authorized to take all steps necessary to implement the terms and conditions of the contract.

Section 4. Authorization of Fund Expenditure. Notwithstanding the limitations imposed upon the Town Manager by the Town's Procurement Ordinance, the Town Manager is authorized to expend budgeted funds to implement the terms and conditions of this Resolution and the access the State of Colorado Master Agreement Number: 188037 (State of Florida's Alternate Contract Source No. 44100000-24-NASPO-ACS), with NASPO Value Point Copiers and Managed Print Services, through Toshiba American Business Solutions, Inc., in an amount not to exceedbudgeted funds.

Section 5. Execution of the Contract. The Town Manager is authorized to execute the Contract in substantially the form attached hereto as Exhibit "A" State of Colorado Master Agreement Number: 188037 and Exhibit "B" State of Florida's Alternate Contract Source No. 44100000-24-NASPO-ACS, with NASPO Value Point Copiers and Managed Print Services, through Toshiba American Business Solutions, Inc., and to execute any required agreements and/or documents to implement the terms and conditions of the contract and to execute any extension and/or amendments to the contract, subject to approval as to form and legality by the Town Attorney.

Section 6. Effective Date. This Resolution shall take effect immediately upon adoption.
